PETITIONER'S TRAVERSE

Respondents' return confirms Petitioner Uriel Mendoza Araiza's entitlement to relief as a Bond Denial Class member under the declaratory judgment in *Rodriguez Vazquez v. Bostock*, No. 3:25-cv-05240-TMC, --- F. Supp. 3d ----, 2025 WL 2782499 (W.D. Wash. Sept. 30, 2025). Dkt. 9 at 3. The Court should accordingly grant Mr. Mendoza's request for a writ of habeas corpus ordering that Respondents release him unless within seven days of this Court's order they administer a bond hearing under 8 U.S.C. § 1226(a). Dkt. 1 at 5 ¶ b; *see also* Dkt. 9 at 4 (agreeing the "appropriate relief would be for him to have a bond redetermination hearing in the immigration court pursuant to 8 U.S.C. § 1226(a)"). The Court should also clarify that the Immigration Judge may not conclude that Mr. Mendoza is subject to detention under 8 U.S.C. §§ 1226(c) or 1225(b)(2). Dkt. 1 at 5 ¶ b. Given that Respondents have not contested Mr. Mendoza's class membership, that the *Rodriguez Vazquez* declaratory judgment recognizes class

members' entitlement to relief, and that the liberty interest at stake is significant, Mr. Mendoza respectfully requests that the Court consider his petition forthwith instead of waiting for the noting date.
