



NORTHWEST IMMIGRANT RIGHTS PROJECT EQUAL JUSTICE WORKS CRIME VICTIMS JUSTICE CORPS FELLOWSHIP

Summary:

Northwest Immigrant Rights Project (NWIRP) will host a fellow over two years as part of the Equal Justice Works Crime Victims Justice Corps. The fellowship will begin on or about June 1, 2018 and end on May 31, 2020. The Equal Justice Works Crime Victims Justice Corps is a legal fellowship program designed to increase capacity and access to civil legal help for crime survivors. A cohort of approximately sixty fellows are placed at nonprofit organizations across the country to provide direct representation to survivors of crimes, including human trafficking, fraud/identity theft, campus sexual assault, and hate crime, and immigrant survivors of crime with meritorious claims for immigration relief, and outreach and education to community partners. All fellows will incorporate crime survivors' rights enforcement into their practice and will receive training from the National Crime Victim Law Institute and other training and technical providers.

This program is supported by an award from the U.S. Department of Justice, Office of Justice Programs, Office for Victims of Crime, Award Number 2017-MU-MU-K131, and private funding. The fellow will be supervised by NWIRP and based in Seattle, Washington.

Description:

- Provide direct legal services to immigrant survivors of human trafficking.
- Provide direct representation to survivors of human trafficking in immigration removal proceedings.
- Provide direct representation to survivors of human trafficking submitting affirmative applications with U.S. Citizenship and Immigration Services and the Department of State.
- Conduct presentations, workshops, legal clinics and individual consultations in English and at least one other language.
- Provide support to NWIRP staff on cases dealing with humanitarian protections for survivors of human trafficking.
- Participate in NWIRP's outreach, community education and development efforts.
- Perform other tasks as required and directed by supervisory staff.
- Contribute to programmatic reporting required under the federal award.
- Collaborate with other Equal Justice Works Crime Victims Justice Corps Fellows
- Actively participate in mandatory in-person training programs including two-day Crime Victims Justice Corps Victim Law Boot Camp training on June 28-29, 2018 in Washington, DC; learning event at the end of the Fellowship; annual three-day Equal Justice Works Leadership Development Training in October/November 2018 and 2019 in Washington, DC; and training calls with the National Crime Victim Law Institute

Qualifications:

The ideal candidate will possess the following qualifications:

- Law degree;
- Admission to the bar of any state in the U.S.;
- Demonstrated commitment to immigrant rights and willingness to support NWIRP's mission, vision, and values;
- A demonstrated commitment to public interest work and desire to assist crime survivors
- Strong writing, communication, interpersonal, and organizational skills
- An ability to provide survivor-centered, trauma-informed, and culturally competent legal assistance to crime survivors
- An ability to work collaboratively in a variety of contexts and with multiple organizations to facilitate comprehensive services to crime survivors
- Ability to begin the fellowship by on or about June 1, 2018 and serve for two (2) years
- Prior experience working with survivors of human trafficking, domestic violence, or sexual assault strongly preferred;
- Fluency in English and Spanish strongly preferred;
- Proficiency in use of web-based software, MS Word and MS Excel.

Salary and Benefits:

The Fellow will receive an annual salary of \$58,232. NWIRP offers a generous benefits package, including 100% of premiums for excellent health, vision & dental plans; 3% employer retirement contributions; paid vacation and health-related leave; subsidized transit pass; position-related travel reimbursement; bar dues; extensive training.
